**Summary of proceedings of the 26<sup>th</sup> Annual General Meeting ('AGM/Meeting')**

The 26<sup>th</sup> AGM of the Members of Gayatri Sugars Limited ('the Company') was held on Wednesday, September 29, 2021 at 12:40 P.M. (IST) through two-way Video Conferencing ('VC')/Other Audio-Visual Means ('OAVM'). The Meeting was conducted in accordance with the circulars issued by the Ministry of Corporate Affairs ('MCA') and the Securities and Exchange Board of India ('SEBI').

Mr. VR Prasad, Chief Financial Officer, welcomed the Members to the Meeting and briefed them on details relating to their participation at the Meeting through audio visual means.

Mrs. T. Sarita Reddy, Managing Director of the Company, chaired the Meeting in the absence of chairperson of the Board. The Chairperson welcomed the shareholders to the Meeting and on requisite quorum being present, called the Meeting to order.

All the Directors of the Company were present at the Meeting through VC from their respective locations except Mrs. T. Indira Reddy, Chairperson of the Board and Mr. T V Sandeep Reddy, Vice Chairman of the Board. The Chairperson welcomed the Directors and requested them to introduce themselves to the Members, who were attending the Meeting through VC.

The Chairperson informed the Members that, Mr. Nilesh Oommen, Chartered Accountant, MOS & Associates LLP, Statutory Auditors and Mr. Y Koteswara Rao, Secretarial Auditor and Scrutinizer for the remote e-voting and the e-voting during the proceedings of the AGM, were also present at the Meeting through VC.

The Chairperson then informed the Members that, the proceedings of the Meeting were also being webcast and could be viewed live by Members by logging in to CDSL website. The Company had taken the requisite steps to enable Members to participate and vote on the items being considered at this AGM.

Since there was no physical attendance of Members and in compliance with the Circulars issued by the MCA and SEBI, Members were informed that the requirement of appointing proxies was not applicable. Further, the Registers as required under the Companies Act, 2013 were available for inspection in electronic mode at the request of the members.

With the consent of the Members present, the Notice convening the AGM for the year ended March 31, 2021 was taken as read. The Chairperson informed that the Auditor's had submitted Qualified Report and the Chairperson deliberated on the same to the members.

The Chairperson then made her opening remarks and statement with respect to her views on the future outlook and its impact on Gayatri Sugars Limited.
